As a valued member of Gulf Credit Union, you have the opportunity to skip a payment on your loan this summer. If you have more than one loan, you can skip a payment for each! Your completed form must be received by **June 10, 2019 for July deferrals** and **July 10, 2019 for August deferrals**. Stop by any GCU location or look at our website for additional details and requirements.

If you make your payments via Payroll Deduction or Direct Deposit, your skipped payment will remain in your Savings Account or your Checking Account. Interest will continue to accrue on your loan during the month you skip your payment. Please make a note that if you take advantage of this skip a payment offer, the final loan payment will be extended by one month.

For only **\$30 per loan**, this is your chance to get the extra summer time cash you need without having to make a loan payment.

**JUST MAKE SURE YOUR LOAN MEETS THE FOLLOWING CRITERIA:**

- Your loan is current
- Any loan must have received at least three (3) consecutive loan payments
- The loan is scheduled for monthly, biweekly, or semi-monthly payments
- The loan has no active disability insurance claim
- Your account is in good standing
